MINUTES BOARD OF EDUCATION May 10, 2010

The School Board of Beresford School District 61-2, Union County, Beresford, SD held their regular meeting at 5:30 p.m. at the south campus. Those Board members present were: President Sue Christensen, Shelby Docken, Ric Morren, Doug Wevik, Dennis McKelvey, Deb Bergland and Clifton Carnes. Absent: none. The Superintendent's report was given by Brian Field, including an update on the South Dakota Coalition of Schools request to have local school boards adopt a resolution in support of the adequacy study. Mr. Field informed the board that the request for support did not have to involve financial support.

During community input time, community members spoke to the board about keeping a certified librarian on staff for the 2010-11 school year and the positive impact a certified librarian can have on the education of the students. One community member expressed her thoughts on seeking parental input regarding the proposed 8 period day/common bell system at the MS/HS for the 2010-11 school year.

The board recessed at 7:09 pm to attend the Senior Academic Awards Ceremony in the HS gym. The board reconvened at 7:34 pm.

The board discussed how they were going to proceed with filling the school board vacancy. Interviews with the two applicants will be held and the board will then appoint a replacement at the July meeting.
