# Watchdog Education Foundation Partners with Farmers Cooperative Elevator of Beresford in "Bushels for Education" Campaign

This month the Watchdog Education Foundation in partnership with Farmers Cooperative Elevator (FCE) of Beresford will kick-off its *BUSHELS FOR EDUCATION CAMPAIGN*. The purpose of this campaign is to raise capital for the Foundation. Area farmers who would like to participate in the Bushels for Education Campaign will fill out a <u>Watchdog Education Foundation Grain Voucher</u> at the FCE office located at 101 N East Street in Beresford. The bushels donated will be priced at the market the day of delivery or the next market day if delivery is made after market close. Checks will be issued to the Watchdog Education Foundation no later than two weeks following the delivery of grain. The delivery of grain must occur between February and August, 2011. The Foundation's goal is to raise 5,000 bushels. If your contribution is 10 bushels or several 100 bushels, every bushel counts and will help enhance and enrich education of local youth.

According to Gary Vande Vegte, a certified public accountant for Van Bruggen & Vande Vegte, P.C. in Orange City, Iowa, "If an operating farmer makes a charitable contribution in the form of an agricultural commodity, the unsold inventory is removed from income before recognition and the farmer receives an income tax, and possible self-employment tax benefit."

# **Watchdog Education Foundation Conducts Quarterly Meeting**

#### "Innovative Education" Grant Guidelines Established

The Watchdog Education Foundation Board held their second quarterly meeting on Wednesday, January 12, 2011 at 4:30 p.m. at the Beresford School District South Campus conference room. The following board members were present: Helen Grace, Chairperson; Gerald Dahlin, Vice-Chair; Sue Christensen, Treasurer; Brian Field, Secretary; and Nathan Jensen, Director. Minutes from the October 13, 2010 board meeting were reviewed and approved by the Board. Beresford High School alumnus Nathan Jensen was appointed and approved as the fifth member of the Watchdog Education Foundation Board.

The financial report was given by Sue Christensen and it was approved by the Board. The Watchdog Education Foundation is a sub-fund of the Beresford Area Foundation and has total net assets of \$8,258.09 as of December 10, 2010. Additional contributions have been made to the Watchdog Education Foundation and they will appear on a future financial statement. Treasurer Christensen reported there have been a total of 42 contributions made to the Watchdog Education Foundation.

The Board reviewed and approved the Watchdog Education Foundation "Innovative Education" Grant guidelines, as well as the grant application. Grants are awarded for innovative and creative educational projects, which are beyond the scope of the regular school budget. Applicants may be one or more teachers, a group of teachers/staff, a teacher-parent group, or another Beresford School District employee group. The project may be for a classroom, a grade level, a school, several schools, or the Beresford School District. Innovative education grants can be:

<u>A new or innovative technology tool that incorporates 21<sup>st</sup> century learning skills</u> for students, a school or classroom;

<u>A one-time event or experience</u> that offers students a unique experience that would not otherwise be available; or

An immediate impact grant that boosts a program or activity to another level.

The Shanna Rae Christensen Memorial Scholarship application was reviewed and approved by the Board. A special scholarship fund was set up by the David and Susan Christensen family in memory of their daughter Shanna Rae. The Shanna Rae Christensen Memorial Scholarship is a sub-fund of the Watchdog Foundation and has total net assets of \$5267.44 as of November 30, 2010. Scholarship recipients will be selected by the Watchdog Education Foundation Board each spring.

- The scholarship will be for a Beresford High School senior whose intended plan of post-high study will be in the area of special education, rehabilitation, or nursing.
- The senior must have two letters of recommendation from individuals who can speak to character and activity involvement.
- The senior must have a 3.0 GPA or higher, demonstrate good moral character, and be involved in community, church and/or school activities.
- Work and/or volunteer experience with special needs children is preferred but not required.

The annual fund raiser for the Shanna Rae Christensen Memorial Scholarship will be from the proceeds generated by the Tri-county Bike Tour. This tour will be held during "Wheels and Squeals" weekend on Saturday, June 18, 2011 at 8:00 a.m. Interested bike tour riders can register on line at www.allsportcentral.com.

The next two quarterly meetings for the Board of Directors are scheduled for March 2, 2011 and June 1, 2011 at 4:30 p.m. in the school district's South Campus conference room.

## Watchdog Education Foundation Conducts First Organizational Meeting

### Shanna Rae Christensen Scholarship Fund Established

The Watchdog Education Foundation Board of Directors held their first organizational meeting at the school district's south campus conference room on Wednesday, October 13, 2010 at 4:30 p.m. The Watchdog Education Foundation is a sub-fund affiliated with the Beresford Community Foundation as administered by and between an agreement with the South Dakota Community Foundation in Pierre, South Dakota.

The following directors were appointed as officers for the Watchdog Education Foundation: Helen Grace, president; Gerald Dahlin, vice-president; Brian Field, secretary; and Sue Christensen, treasurer. The fifth director is Nathan Jensen. The Board adopted by-laws for the Watchdog Education Foundation and set their quarterly meeting schedule. The directors will meet quarterly on the second Wednesdays on January 12, 2011; March 9, 2011; and June 8, 2011 at 4:30 p.m. in the school district's south campus conference room.

The Board reviewed and approved the Foundation's financial report. As of September 30, 2010, the total net assets of the Watchdog Education Foundation were \$6,357.61. Since then, a special scholarship fund has been established in the amount of \$5000 and a memorial in the amount of \$1697 has been contributed to the Foundation. Altogether, the Foundation would have an account balance of \$13,054.61. At this time, there are no dollars available for distribution.

A special scholarship fund was set up by the David and Susan Christensen family in memory of their daughter Shanna Rae. The fund agreement was set up with the South Dakota Community Foundation as a sub-fund of the Watchdog Education Foundation, and affiliated fund of the Beresford Area Foundation.

The scholarship will be for a Beresford High School senior whose intended plan of post-high study will be in the area of special education, rehabilitation, or nursing. The senior must have two letters of recommendation from individuals who can speak to character and activity involvement. The senior must have a 3.0 GPA or higher, demonstrate good moral character, and be involved in community, church and/or school activities. Work and/or volunteer experience with special needs children is preferred but not required. The Watchdog Education Foundation Board will make the decision in the spring time as to who will receive the annual Shanna Rae Christensen Scholarship.
